विश्वविद्यालय कार्यपरिषद् की बैठक दिनांक 06.03.2023 के अध्यक्ष के अनुमति से निर्णय क्रमांक 02 एवं छत्तीसगढ़ शासन, उच्च शिक्षा विभाग, मंत्रालय, महानदी भवन, नवा रायपुर अटल नगर, रायपुर से प्राप्त पत्र क्रमांक एफ 3-12/2023/38-2 दिनांक 17.01.2024 के अनुक्रम में नवीन Ordinance No. 199 - "M.Ed. Special Education (ID)" माननीय कुलाधिपति महोदय द्वारा अनुमोदित को अंगीकृत किए जाने का निर्णय लिया गया, जो निम्नांकित है -

Ordinance No- 199

M.Ed. Special Education (ID)

(Master of Education, Spl. Edu.)

(E.C. under 06-03-2023)

1. Eligibility :

- 1.1: A candidate who has successfully passed B.Ed. spl.edu. with minimum 50% marks in respective disability area from a recognized university or any other degree considered equivalent to B.Ed. spl.edu. from an affiliating university and / or teaching department under any University recognized by UGC with RCI registration.
- 1.2: A candidate who has successfully passed the B.Ed. General course and has successfully completed Diploma in Education Special Education in respective disability area recognized by the rehabilitation Council of India with minimum 50 % marks in each course.
- 1.3: A candidate with B.Ed. in particular specialization may be allowed for M.Ed. cross disability/ multicategory (as and when offered) but the reverse is not allowed B.Ed. with multi-category should not be admitted for specialization in a single disability at the M.Ed. level, however as per CBCS these can be admitted to B.Ed. Spl. Edu. Area C Courses and complete the specialization courses to qualify for a particular disability on completion of area C, these can be admitted to the M.Ed. Spl. Edu. In a specific disability.
- 1.4 : A student with B.A. /B.Sc. / B.Com. B.Ed. spl. Edu. (4 years Integrated)
- 1.5 : A Candidate should have valid RCI registration.
- 1.6: The reservation and **other relaxation** for SC/ST/OBC/PWD and **other categories** shall be as per the prevailing rules of the state government.

2. DURATION OF THE COURSE:

The duration of the Course is two academic years, consisting of four semester. Which can be completed in a maximum of three years from the date of admission to the program.

3. Admission procedure:

Admission shall be made on merit on the basis of marks obtained in the qualifying examination and / or in the entrance examination or any other selection process as per the state government and the university.

4. Attendance:

In the theory and practical papers attendance of student teachers must be 80% and in internship should be 90%. The relaxation can be availed as specified in the ordinance 6 of the university.

5. Assessment :

5.1 The examination shall consist of two parts, namely

Part I... Theory and

Part II ... Practicum / Internal Assessment in each semester.

The classification and division in the theory **part I** will be as under-

1st division – 60% and above marks.

2nd division- 45% and above but less than 60% marks.

3rd division- 33% and above but less than 45% marks.

Fail – Below 33%

In each theory paper the candidate should obtain minimum 25% marks.

C) The classification and division in the practicum **Part II** will be as under –

1st division- 80% and above marks.

2nd division – 60% and above but less than 80% marks.

3rd division - 50% and above but less than 60 % marks.

Fail – below 50 % marks.

- The theory paper in each semester should have some categories. Such as core studies, Engagement with field as part of course, Elective course, Specialization and project presentation,. A candidate should obtain 33% marks of aggregate in theory papers and 50% in practical, separately.
- If any student fails in theory paper or in practical he /she can continue in the next semester and will be allowed to appear as ATKT to maximum 2 times in two papers. However one candidate has to clear all the back papers in a maximum duration of three years from the date of admission.

6. **Curriculum program implementation:**

Syllabus, assessment and examination scheme shall be as per the NCTE norms and RCI recommendation and as approved by the BOS (Board of studies).

6.1 Internal assessment of each candidate is to be carried out through out the course of each candidate is to be maintained.

6.2 Every student has to complete practical work as per syllabus approved by BOS. and have to submit a project, dissertation, & copy record. An external examiner will evaluate the student's performance of dissertation (any selective problem or topic) and will also take a viva voce examination.

6.3 A student shall have to opt for one elective as per provision provided in course

7. **fees :** The institutions shall charge fee as prescribed by the affiliating body / state government in accordance with the provision of the NCTE regulation 2002/ prescribed by RCI as amended from time to time and shall not charge donation, capitation fee etc. from the students.

8. All the other relevant rules & regulation will be abounded time to time as per university guideline.


