The Academic Council in its meeting held on June 11, 2024 at Vice Chancellor Secretariate, at 12.00 noon has approved this Regulation-131 and finalized the roles of the Departmental Research Committee (DRC) as outlined below -

		2. To provide all eligible candidates with a list of
		supervisors for each subject, indicating the number of
		vacant seats.
		3. To screen the applications received (in the prescribed
		proforma duly signed by the candidate and the
		proposed supervisor) for admission to the Ph.D.
	_	program from the eligible candidates (exempted

		conducted by the University).
		4. To conduct interview of all the eligible candidates and
		prepare a list of selected candidates along with the
		assigned supervisor.
		5. To conduct a six-monthly progress review of the Ph.D.
		student (preferably through a PowerPoint presentation)
		at the end of every six months of his/her research work.
		at the end of every six months of ms/net research work.

- 3. Written test will be conducted by the University, and admission of eligible candidates in the subject concerned will be finalized by the DRC of the concerned subject/ group of subjects/ interdisciplinary subjects/subjects run by the departments of interdisciplinary nature (e.g. Regional Studies/ Life Sciences/ Centre for Basic Sciences, etc.) on the basis of presentation/ personnel interview.
- 4. Admission of the eligible candidates for Ph.D. Program will be decided on the basis of mutual consent of the candidate and the supervisor as prescribed in Ordinance 45(5) and the performance of the candidate before the DRC.
- Reservation policy of the state government will be applicable for admission of students in Ph.D. program.

- Eligibility of the candidate passing the Ph.D. Entrance Examination (conducted by the University) will be valid for the one/current academic session only as per UGC letter No. F.4-1 (UGC-NET Review Committee)/2024 (NET)/ 140648 dated March 27, 2024.
- 7. Candidate who qualify in SET examination conducted in the Chhattisgarh State shall be exempted from appearing at the entrance test and selection shall be based on interview.
- In case of any dispute, the decision of the Vice Chancellor will be final and binding for all the stake holders.
