विश्वविद्यालय की विद्यापरिषद की बैठक दिनांक 11.06.2024 के निर्णय क्रमांक 06 में Revised Regulation No.172- Admission of International Students का अनुशंसा किया गया। अनुशंसा का अनुमोदन कार्यपरिषद की बैठक दिनांक 12.06.2024 के पूरक विषय सूची क्रमांक–01 में अनुमोदित किया गया है जो कि निम्नांकित है:–

# Revised Regulation No. 172 Admission of International Students

(E.C. Under 12.06.2024)

In line with the provisions of 'National Education Policy-2020', Pt. Ravishankar Shukla University, Raipur, Chhattisgarh, India is committed to fostering a vibrant international learning environment. To facilitate and attract talented international students, Pt. Ravishankar Shukla University has framed this regulation as per the norms of the University Grants Commission, Govt. of India.

#### 01. Definition of foreign student:

A foreign student is one who holds a valid passport /citizenship of a country other than India.

#### 02. Categories of foreign students:

- (a) Self-financing student.
- (b) Students nominated/coming through the Cultural Exchange Fellowship Programs of the Indian Council for Cultural Relations (ICCR), Government of India, and other Central Government Organizations.
  - (c) Student / Teacher working under a recognized Research Scheme of the Government of India.

#### 03. Seats Reserved for Foreign Students:

There are 25% supernumerary seats reserved for foreign students, over and above the total sanctioned seats in different teaching departments *viz.*; Chemistry, Physics and Astrophysics, Biotechnology, Electronics, Life Sciences, Pharmacy, Mathematics and Economics. The competent authorities of the University may increase the seats considering the infrastructure, faculty and other requirements on a case-to-case basis.

# 05. General Guidelines:

The foreign student must have an appropriate Student Visa or Research Visa for the study program. The applicant should contact the Indian Embassy or High Commission in his/her home country for more information on the type of visa needed. In case of students from restricted countries (Afghanistan, China, Iran, Pakistan, Iraq and Sudan), the application must be forwarded through the Indian Embassy or the High Commission in their respective countries. Candidates seeking admission under a 'Cultural Exchange Fellowship program' are required to apply through the Indian High Commission/Embassy in their respective countries. #### 06. Language of Instruction:

ENGLISH will be the only language for teaching and research, except for courses related to languages, such as Hindi, Chhattisgarhi, etc.

#### 07. Eligibility Certificate:

The admission of the foreign students for the course will be based on the equivalence of entry qualification held by them. The fee for an eligibility/equivalence certificate is US\$ 100.00.

#### 08. Medical Insurance:

Procuring Medical Insurance from the date of reporting till the valid period of the course at the University is mandatory and has to be procured within two months from the date of arrival in India.

#### 09. Fee Structure:

A foreign student is required to pay the fees at the time of admission, as per the details given elsewhere (Please see the Guidelines for the Admission of Foreign Students). The payment can be made either in US Dollars (USD) or in Indian Rupees (INR). The payment can also be made through a wire transfer in the account of the Registrar, Pt. Ravishankar Shukla University. Details of bank account can be obtained on request from the Registrar, Pt. Ravishankar Shukla University, Raipur, India. The fees are liable to revision and the students will have to pay the revised fees, as and when applicable.

### 10. Hostel Accommodation:

There are limited hostel accommodations available on the campus. Therefore, a foreign student desirous of taking accommodation on the University campus shall have to apply separately in a prescribed Hostel Admission Form (details of the hostel fee are mentioned in the Guidelines for the Admission of Foreign Students). The accommodation will be provided on a first-come first-serve basis.

### 11. Offer of Admission:

Offer-letter for admission to the University Teaching Department and hostel will be communicated to the foreign students through e-mail only. Offer will be made based on recommendations received from the University Teaching Department, and will be informed through e-mail. Students applying through ICCR will be intimated through ICCR.

#### 12. Admission Procedures for Self-Financing Students:

The application form with copies of supporting documents should be sent to the Head of the specific University Teaching Department to which the foreign student wants to be admitted (the contact address is available at the university's website: www.prsu.ac.in). To expedite the processing, a scanned copy of the application form with the supporting documents can also be emailed to registrarprsu@gmail.com

# 13. Supporting documents required at the time of admission:

- (a) Academic transcripts (with the explanation of assigned grades)
- (b) Two recommendation letters, one from a faculty member who has taught the applicant earlier, and another from the authorities of the academic institution where the applicant may have studied prior to seeking admission to Pandit Ravishankar Shukla University, Raipur, India.
- (c) Scanned copy of relevant passport pages showing nationality and personal details
- (d) Statement of purpose (in about 500 words)
- (e) 'Medical Fitness Certificate' from a doctor attesting to their physical and medical fitness.
- (f) Two (2) passport-size color photographs

# 14. Recommendation of Selection Committee:

The department concerned will constitute a selection committee (case to case basis) with at least 3 (three) members headed by the 'Head of the Department'. Admission offer letters will be made based on the recommendation of the department.

# 15. Examination and Award of Degree:

The procedure for examination, issue of mark sheet, issue of passing certificates and degree will be same as for the Indian student of Pt. Ravishankar Shukla University.

#### 16. Dispute:

If any dispute arises regarding the interpretation of any provision of this regulation or on matters and situations not covered by this 'Regulation', the matter shall be referred to the Vice Chancellor, Pt. Ravishankar Shukla University, Raipur, whose decision thereon shall be final and binding.
