A functional website is necessary for Re-Accreditation by NAAC.

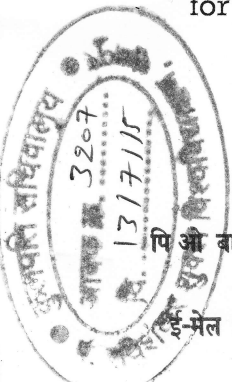
