Five year Integrated Course in Arts & Science

- 1. The five year integrated course has been broken up in to five parts. Parts I to III shall be known as BA/BSc Course and Parts IV and V shall be known as MA/MSc Previous & Final course. This course shall be run by the University only in its Teaching Departments/Schook of Studies.
- 2. A candidate after passing 10-2 examinations of Chhattisgarh Board of Secondary Education, Raipur or any other examination recognized by the University or Chhattisgarh Board of Secondary Education as equivalent thereto, shall be eligible for the admission in Part 1 of the five year integrated course in the University Teaching Departments/Schools of Studies 1. The procedure of admission shall be announced from time to time.
- 3. A candidate who has been admitted in Part I of the five year integrated course, has attended a regular course of study in the UTD/School of Studies of the University for one academic year shall be eligible for appearing at the Part-I examination of Arts/Science subjects.
- 4. A candidate who, after passing Part I examination of the University, has attended a regular course of study for one academic year in UTD/SOS of the University, shall be eligible for appearing at the Part II examination of five year integrated course in Arts/Science subjects.
- 5. A candidate who, after passing Part II examination of the University, has attended a regular course of study for one academic year in UTD/SOS of the University, shall be eligible for appearing at the Part III examination of five year integrated course in Arts/Science subjects.

6. BA/BSc Course

BA/BSc course will be a three year degree course. The structure of the course shall be as under:-

- (1) One compulsory subject consisting of two papers each in each of Parts I to III
- (2) Three elective subject:
 - (a) One major subject consisting of two papers each in Part I & II and six papers in Part III.
 - (b) Two other subjects each consisting of two papers each in Part I & II only. These two subjects will not be a part of the Part III course.

In the subjects where practicals are provided ,there shall be practical papers also in addition to theory papers

(ii) Elective Subjects: One subject from each of the (including one major following Groups.
& two other subjects)

- In order to pass at any part of the first three year examinations, an examinee must obtain not less than 36% of total marks in each subject. In subjects where both Theory & Practical examinations are provided, an examinee must pass separately in both theory and practical examination.
- 8. The result of each part examination shall be determined separately.
- 9. No division shall be assigned on the result of part 1 and 11 examinations. The division of the candidate shall be determined on the basis of the aggregate of the total marks obtained in Part I. II and III examinations.
- A Candidate after successful completion of the first three parts obtaining 60% or more marks in aggregate shall be placed in First Division Honors. The examinee who has secured 48% but less than 60% of marks in aggregate in all three parts shall be placed in Second Division Honors. The examinees securing 30% or more but less than 48% marks in aggregate of all the Three parts examinations shall be placed in Third Division, and they shall not be awarded Honors.

II. M.A./M.Sc. Course

If a candidate after passing part I, II and III examinations, desires, he may be admitted in Part IV which shall be known as MA/MSc. Previous in any of the following subjects.—Geography 2. Psychology 3. Comp. Religion & Philosophy

- 4. Sociology 5. Anthropology 6. Linguistics 7. Feonomies
- 8. History 9. Ancient Indian .History Culture and Archology
- 9. Physics 11. Chemistry 12. Electronics 13. Geology 14. Bio-Science 15. Microbiology 16. Biotechnology.

In the event of vacancy of seats in any of the above Subjects, students coming from the affiliated colleges/other Universities may also be admitted as regular students provided they qualify the entrance test specifically designed for them.

- 12. A candidate after prosecuting a regular course of study for one academic year in UTD/School of Studies shall be eligible for appearing at part IV, i.e. Previous examination of any one subject mentioned in para 11 above.
- 13. A candidate after passing the part IV, i.e. Previous Examination and has attended a regular course of study in UTD/School of Studies for one academic y ear shall be eligible for appearing at the part V, i.e. Final examination.
 - 14. In order to pass in Part IV & V examinations a candidate must obtain not less than 36% of total marks in aggregate in each part in the subject. In subjects where both theory and practical examinations are provided an examinee must pass separately in both theory and practical examinations.
 - 15. The result of each part examination shall be determined independently and candidate will have to pass separately at Part IV (Previous) and part V(Final) examinations.
 - 16. No division shall be assigned on the result of part IV/previous examination. The division in which a candidate shall be placed at the part V (Final) examination shall be determined on the basis of the aggregate of total marks obtained in the Poxt IV(Previous) and the V(Final) examinations.
 - 17. The candidates obtaining 60% or above marks in aggregate of part IV(Previous) and part V(Final) examinations shall be placed in first division. The candidates obtaining less than 60% and not less than 48% of marks in aggregate of the part IV(Previous) and part V(Final) examination shall be placed in second division.
