

Revised Ordinance No. - 172

Master of Physical Education

(Semester)

- I. The duration of the course shall be of Four Semesters.
- II. A candidate who –
  - (i) After taking a bachelor's degree in Physical Education of this University or of any Indian University recognized by this University.
  - (ii) After obtaining a postgraduate diploma in Physical Education of at least one year's duration awarded by an Indian University or a Board appointed by the Education Department of state.
  - (iii) After obtaining Indian or Foreign qualification recognized as equivalent to those mentioned in (a) or (b) above by this University has regular course of study for one year shall be admitted to first year examination for the degree of Master of Physical Education (M.P.Ed.) subject to being selected on the basis of admission tests prevailing in the year when admission is sought in this University. Provided that he/she shall has passed the examination for Bachelors Physical Education, Diploma in Physical Education of having any other qualification equivalent to Bachelor of Physical Education securing 45% of marks in theory. 5% relaxation should be given to SC and ST candidates.
- III. A regular course of study means candidate who have attended atleast 75% of the lectures delivered and the practical's held in each subject of the course.

This attendance will be calculated separately for each subject and each activity practical sessions.
- IV. The medium of instruction shall be Hindi/English.
- V. \*\* A candidate who, after passing the semester examination shall be admitted to the next semester. However, a candidate failing in not more than two papers in any semester shall be declared ATKT and permitted to join the next semester, in which case a candidate will appear in the paper(s) in which he had failed in the previous semester along with the papers of present semester. The result of fourth semester examination shall be declared only after a candidate has cleared all the three semester examination.
- VI. The marks obtained by a candidate in all papers of four semesters shall count together for a place in the pass list of the final semester examination; no division shall be assigned on the basis of each semester result. Division

for M.P.Ed. shall be awarded on the basis of cumulative marks obtained by the candidate in all the four semester theory and paper.

- VII. \*\* An ATKT candidate will be given three attempts to clear the failed papers (Main exam + two ATKT exam)
- VIII. Division shall be assigned on the following basis:-
1. First division 60% and above of the aggregate marks. Second division 48% and above but below 60%. Third division 36% and above but below 48% of the aggregate marks, merit list for M.P.Ed. shall be based on cumulative marks in theory and practical.
- IX. The tuition, examination and other fees shall be as decided by the University from time to time.
- X. \*\* The M.P.Ed. course shall be divided into four semesters. Each semester shall have four theory papers each of 100 marks. The total of 100 marks of paper shall be divided into 80 marks final exams and 20 marks sessional. For passing the candidate should obtain 36% marks each, in final exam as well as sessional of each paper separately. All semester shall have practical examination of 200 marks each, i.e. 100 marks final practical exam and 100 marks sessional. A candidate shall secure 40% of marks each, for passing the final practical exam as well as sessional of each practical separately.
